
ORDER

1. **THIS COURT ORDERS** that the short-form and long-form Notices of Certification and Settlement Approval (“the Notices”) are approved.
2. **THIS COURT ORDERS** that the costs associated with disseminating the Notices in accordance with the Notice Plan appended as Schedule B to the Order approving the MKW Settlement, shall be paid from the net settlement funds of the MKW Settlement.
3. **THIS COURT ORDERS** that CA2 Class Action Claims Administration Inc. (“CA2”) is approved as the notice administrator to perform the functions set out in the Notice Plan.
4. **THIS COURT ORDERS** that CA2 shall serve and file an affidavit with the Court within 60 days of the date of this Order, or as soon as possible thereafter, confirming that the terms of the Notice Plan have been fulfilled. *BL*
5. **THIS COURT ORDERS** that the Plaintiffs and CA2 may use the Class Members' personal information contained in the Class List maintained by CA2 for the purposes of providing the Notices to the Class.
6. **THIS COURT DECLARES** that the use of the Class Members' personal information for the purposes of providing the Notices in accordance with the Notice Plan does not breach the Class Members' statutory and common law privacy rights. *BL*
7. **THIS COURT ORDERS** that there shall be no costs of this motion.
